TERMS AND CONDITIONS

- You are entirely responsible for getting your own insurance to cover yourselves and your personal belongings whilst staying at the property. We will not be liable for any act, neglect or default on the part of any person. Neither will we be liable for any accident, damage, loss, injury, expense or inconvenience, whether to person or property.
- 2. Bookings are made by the week (unless by prior arrangement). Check-in is from 16:00hrs on the day of arrival and check-out is at 10:00hrs on the day of departure. In the case of long let's, alternative times can be arranged in advance.
- 3. If your booking is made more than six weeks prior to the first day of the letting period, a holding deposit is chargeable at the time of booking. Full payment is due six weeks prior to the first day of letting.
- 4. If your booking is made within six weeks of the letting period, the rental sum are to be paid in full by bank transfer to secure your booking
- 5. The deposit is held in case of any accidental damage sustained during the letting period, and will be repaid following inspection of the property and return of fully functioning keys and garage fob. Missing key will be charged € 200,-
- 6. If you request a cancellation more than six weeks in advance of the letting period, the balance of any monies paid will be returned to you. The owner also reserves the right to retain the balance of the rental monies should it not be possible to re-let the property for this period.
- 7. The number of people occupying the property must not exceed the number on the booking form.
- 8. You agree to keep the property and all fittings, furniture equipment and other contents in or on the property in a like state of repair and condition as at the commencement of the letting.
